Insurance certificates must:

- 3. Contain the following wording under the "Description of Operations/Special Provisions" section:

Certificate holder is named as Additional Insured as respects General Liability and Automobile Liability including form #CA9947 and Loss Payee as respects Props, Sets, and Wardrobes, and Loss of Use, rental/leased to the named insured.

4. Be issued by the company's insurance agent. These are legal documents (contracts) and in order for them to be valid and for 20th Century Prosp to be properly covered, they must come directly from your company's insurance agent. We do call the agency to confirm coverage.

If possible, the certificates should be faxed to 20th Century Props at least one day in advance of your order's pick-up date. They should be faxed to the attention of the Credit Department at (323) 461-3643.
